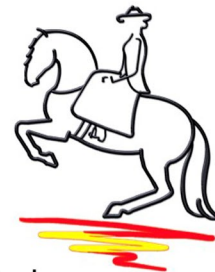


## **ATTENDANCE RULES for COURSES organized by A.E.M.A.**



All courses organised by A.E.M.A are carried out in support and promotion of side saddle riding in Spain, to facilitate and bring knowledge of this type of riding to enthusiasts throughout the country.

The material used and the knowledge presented in these courses are the exclusive intellectual property of AEMA or of the person who teaches the course; they are protected by intellectual property laws, therefore, their total or partial reproduction on any medium is prohibited.

All teaching provided and material used during the course (recording, broadcasting, manuals, images, saddles, etc.) in the name of or with the name of the Association is protected by intellectual property, and its copying, use or reproduction on any medium by individuals, entities or organizations without the express authorization of AEMA, with its supervision and accreditation, is prohibited.

Given the impossibility of having total control over the individual use of said materials, the recording, reproduction and copying of the activities or courses taught by AEMA is prohibited. Taking photos or videos is prohibited, as well as their dissemination, copying or reproduction on any medium. AEMA, as organizer of the activity, reserves the exclusive rights to texts, images, filming of videos or recordings of audio of the participants and all the content developed during the course without any compensation.

### Attendants

1. All individuals who have paid the registration fee will be entitled to attend.
2. All persons and companions who wish to stay at the facilities during the course must have registered as spectators. Except during meal times during which admission of companions not registered for the course is planned.
3. Given the impossibility of carrying out a prior check on the level of riding of the participants, it is understood that those who register and attend the course do so because they consider themselves capable of doing so and have the necessary horsemanship skills to execute the activities that are carried out. However, it is not obligatory to carry out all the exercises if, during the course of the training, the interested party considers that she is not prepared to carry out some of them, and expresses her desire not to do so.
4. All participants who take part in the training must have sports insurance. AEMA takes all possible precautions, however, those who attend the course do so under their own responsibility when practicing horse riding, thus AEMA is not responsible for any incidents.
5. In addition to the Sports Insurance, it is required to sign a liability waiver form.
6. Attendees must come with appropriate clothing for the activity, riding breeches (without decorations, embroidery, silicone or seams on the seat or the part that is in contact with the saddle) and riding boots (boots or gaiters that do not have decorations, zippers or buckles in contact with the saddle, the outer part of the right leg and the inner part of the left leg). The use of a protective helmet is also recommended.
7. Minors must mandatorily wear a helmet and appropriate protection and present authorization from their father, mother or guardian.
8. Those who come to the course with their own horse must have civil liability insurance. However, if AEMA considers that a horse endangers the normal development of the course, it reserves the right to refuse or interrupt its presence in said course.
9. Those who bring their own equipment, saddle, halter, etc. must ensure that it is in perfect working order. AEMA reserves the right to inspect said material and prohibit its use if it considers it unsuitable for use. It is not necessary to have a saddle, but it is recommended that those who have one bring it to the course to receive information on its suitability.
10. The interested party undertakes to comply with all these rules with their attendance. In the event of breaching any of the aforementioned rules, AEMA reserves the right to refuse admission or interrupt their presence in said course.

In the event that attendees do not agree with the established rules, they will have the right to a full refund of the course fee, always before the start of the course. After the start of the course, they will lose any right to a refund.

The interested party undertakes to comply with all these rules with their attendance. In the event of breaching any of the rules mentioned above, AEMA reserves the right to not admit or interrupt their attendance at the course.
